

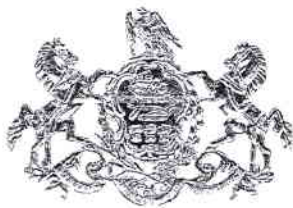

Please be advised that pursuant to the Act of Feb. 14, 2008 (P.L. 6, No. 3), commonly referred to as the Right-To-Know Law, I am hereby making a request for copies of contracts and documents.

Specifically, I am requesting a copy of any all documents pertaining to agreements made within the last two years which include as parties or otherwise mention one or more of the following parties: the Commonwealth (or any of its agencies), the Sports and Exhibition Authority of Pittsburgh and Allegheny County, the Pittsburgh Penguins; Don Barden, and/or PITG Gaming, LLC.

In order to facilitate the provision of these documents sooner than the statutory guideline of five days, I will arrange to have these items picked up at your offices immediately upon notification from you.
